INSTALLATION TIPS

Install in the 8" Everpure IMF Housing

Be certain that end gaskets are in place

Flush cartridges by running water through system for five (5) minutes at full flow

OPERATION TIPS

Not recommended for main line water applications with flow rates exceeding 3.0 gpm (11.4 Lpm)

Do not use this cartridge on water that will be carbonated as carbonation quality may be affected

Replace cartridge when flow rate becomes inconveniently slow or before rated capacity is reached


It is recommended to replace cartridge at least once a year
